

1. Responsibilities of the Institutions

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of resources. Accordingly, the functioning of any exchange and cooperative programs based on this MoU shall be conferred and determined between the two institutions. It is further expected that both the institutions will be compliant with all applicable legislations of Government of India and State and University policies.

2. Duration and Option to Amend, Extend or Terminate

This MoU will become effective when signed by authorities of both institutions. The MoU will remain in effect for five years from the date of signature given below, and may be renewed or amended by mutual understanding of the institutions. The institutions agree to periodically review the activities undertaken for renewal. Either authority may terminate this MoU at any time by providing written notice prior to three months before such termination to the other authority.

3. General Terms



4. Signatures


This MoU shall enter into force on the date of the signing by qualified representatives of both institutions.
